## Terms and Conditions

At Doggonit! Doggy Daycare Inc., we believe in a holistic approach to caring for all dogs. We are committed to providing a healthy, safe place for your dog(s) to stay while making it as fun and stress free as possible. We believe in lifelong immunity from puppy-hood vaccinations and do not require that vaccines be given every year. We do require a copy of the latest Titer test for your dog (Titer tests should be done every 2 years). If you are vaccinating your dog, please bring in proof of vaccinations.

Please pay special attention to the health of your dog before boarding or using daycare with us and make sure he/she is healthy and free from the following:

- Kennel cough
- Fleas, lice or any external parasites
- Internal parasites
- Parvo, Rabies, Distemper or any other contagious disease
- Eye infection, runny nose, vomiting or diarrhea

As the health and safety of all of our guests is of the utmost importance to us, we reserve the right to refuse any dog at our discretion if we feel that these conditions are not met.

I, the undersigned, waive any claims against Doggonit! Doggy Daycare Inc., hereinafter referred to as Doggonit!, for loss or damages to my dog, due diligence and care having been exercised. I have given Doggonit! permission to care for my dog and understand that I am solely responsible for any damage or harm caused to or by my dog. I agree that in entrusting my dog to Doggonit!, they have relied on my representation that my dog is in good health and has not harmed or shown aggressive behavior toward any person or dog prior to this date. If my dog becomes seriously ill and my designated veterinarian is not available, Doggonit! will consult a vet of their choice; all such expenses shall be paid promptly by me, the owner of the pet/undersigned.

Employees at Doggonit! are trained in first aid. In case of injury, accident or any other medical issue that arises, I allow Doggonit! to treat injuries as necessary while on the premises. Doggonit! acknowledges that while dogs are on the premises and under their control for boarding and daycare, they will exercise the utmost diligence of care to protect the health and safety of the dogs. I agree that Doggonit! has no liability for damage or loss to the dog or myself (the owner) as a result from unavoidable acts of nature and fire.

I hereby waive and release Doggonit! and its employees from any and all liability of any injury or damage which my dog may obtain, including specifically, but without limitation to, any injury or damage resulting from the action of any other dog, and I expressly assume the risk of such

damage or injury while my dog is on the premises of Doggonit! I understand that attendance at a doggy daycare or kennel is not without risk to my dog and even with the greatest amount of care, my dog may be exposed to injury.

I also agree that at the completion of the agreed upon boarding or daycare time, if the dog is not picked up by myself (the owner) and payment of all charges are made in full, Doggonit! will notify me by certified mail at the address shown above. The dog will be held for seven business days from the date of mailing the notice. At the end of the seven day period, if there is no response from me (the owner), the dog will be considered abandoned and will become the property of Doggonit! The dog will then be adopted out to a caring home at the discretion of Doggonit! Any proceeds from the adoption will be applied to my (the owner's) outstanding invoice..

Should I (the owner) return for the dog after it has been considered abandoned, I (the owner) may obtain the dog back, at the discretion of Doggonit!, but will be charged for any additional days and food required to board the dog at the current daily boarding rate of Doggonit!.
